

Rocky Mountain Grand Slam Giveaway 2022 (the “Sweepstakes”)

Official Rules

NO PURCHASE NECESSARY. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. ODDS OF WINNING WILL DEPEND ON THE TOTAL NUMBER OF ELIGIBLE ENTRIES RECEIVED PER MONTHLY ENTRY PERIOD AND THROUGHOUT THE DURATION OF THE SWEEPSTAKES.

ELIGIBILITY: Sweepstakes is open only to legal residents of the United States (including its commonwealths, territories, and possessions) who are twenty-one (21) years of age or older at time of entry. HOW TO ENTER: Sweepstakes begins at 9:00 a.m. Mountain Standard Time (MST) on 4/1/2022 and ends at 11:59 p.m. Mountain Standard Time (MST) 9/30/2022 (hereafter, “**Sweepstakes Period**”). The Sweepstakes Period will be divided into monthly entry periods (each, a “**Monthly Entry Period**”) as indicated in the below chart. The official timekeeping clock shall be the Sponsor’s clock. Limit one (1) entry per person per monthly entry period. Additional entries beyond the specified limit will be void. Entries to any Monthly Entry Period will not roll over and will not be included in subsequent Monthly Entry Periods.
